

APPROVING THE REGULATIONS FOR THE PREVENTION OF VIOLENCE, RACISM, XENOPHOBIA AND INTOLERANCE IN SPORT AND THE NORMS FOR ADMISSION TO LALIGA STADIUMS.

Royal Decree 203/2010

Sports grounds with video surveillance for the safety and security of those attending and participating in the fixture.

REASONS WHICH WOULD RESULT IN REFUSED ENTRY TO, OR REMOVAL FROM, THE SPORTS GROUND:

- 1** Involvement in altercations, rows, fights or public disturbances.
 - 2** Introducing, bearing or using any kind of weapon or object which might be used to the same effect.
 - 3** Introducing objects weighing in excess of 500g which are liable to be used as projectiles.
 - 4** Introducing or being in possession of flares, firecrackers, explosives or inflammable materials in general.
 - 5** Being under the influence of alcoholic beverages, narcotics, psychotropic substances, stimulants or similar.
 - 6** Introducing or selling any type of alcoholic beverages, narcotics, psychotropic substances or stimulants.
 - 7** Introducing, displaying or producing banners, flags, symbols or any other signs that incite violence or terrorism.
 - 8** Chants, expressions, noises or attitudes that incite violence or terrorism.
 - 9** Pitch invasions.
 - 10** Having been sanctioned with a ban from any sports ground for as long as the ban is in effect.
 - 11** Carrying out any visiting fan activities in the local area which might constitute a danger to public order and safety.

Furthermore, ticketholders agree not to transmit, distribute, sell (or help to sell) any description, annotation, image, video, audio file, data, statistic or any other type of reproduction of the event other than for personal and private use, with failure to comply with any of the abovementioned obligations also constituting a reason for removal from the sports ground.

ACCESS REGULATIONS FOR ALL THE SPECTATORS

AWAY FANS TICKETS

WE INFORM YOU THAT FOLLOWING SPANISH LAW (RD 203/2010) AWAY FANS TICKETS WILL BE SOLD THROUGH THE VISITING TEAM AND IN A SEPARATE SECTOR FROM VALENCIA CF FANS. THE V.C.F. CLUB RESERVES THE RIGHT TO DENY THE ACCESS TO FANS OF THE VISITING TEAM CARRYING TICKETS OBTAINED BY ANY OTHER MEANS AND THAT ARE NOT LOCATED AT THE AWAY FANS SECTOR.



TICKETS OR ANY VALID DOCUMENT THAT GRANTS THE ACCESS TO THE STADIUM ARE PROPERTY OF THE VCF AND ITS USE IN AN UNAUTHORIZED OR IRREGULAR MANNER WILL SUPPOSE ITS WITHDRAWAL.



SPECTATORS MUST KEEP THEIR TICKETS OR SEASON PASS WITH THEMSELVES AND PRESENT THEM TO AUTHORIZED PERSONNEL IF REQUIRED. (VCF EMPLOYEES, PRIVATE SECURITY, STEWARDS, POLICE) NOT BEING ABLE TO PROVIDE A VALID TICKET MIGHT CAUSE STADIUM EJECTION.



IT IS FORBIDDEN TO INTRODUCE TV CAMERAS AND PROFESSIONAL MICROPHONES UNLESS OTHERWISE AUTHORIZED BY VCF.



NO SMOKING. THE USE OF VAPERS, ELECTRONIC CIGARETTES OR SIMILAR IT'S ALSO PROHIBITED.



SPECTATORS HOLDING A TICKET OR SEASON PASS WILL HAVE ACCESS EXCLUSIVELY TO THE SEAT IDENTIFIED ON THE FRONT SIDE OF THE DOCUMENT. ACCESS TO A DIFFERENT ZONE OR SEAT IS NOT PERMITTED.



AS RD 2816/1982, ARTICLE 59, ACCESS INTO THE STADIUM WILL NOT BE GRANTED WHILE IN POSSESSION OF LARGE/BULKY OBJECTS, STROLLERS OR OTHER OBJECTS THAT MAY BE CONSIDER OBSTACLES IN THE EVENT OF AN EVACUATION.



IT IS ALSO FORBIDDEN THE ACCESS INTO THE STADIUM WITH LARGE BAGS THAT EXCEED THE FOLLOWING MEASURES. 44X30X22 CM (TALL/LONG/WIDE).



NO RE - ENTER

RE ENTRY INTO THE STADIUM IT IS NOT ALLOWED.



SPECTATORS WITH REDUCED MOBILITY WILL ONLY BE ABLE TO ACCESS TO DESIGNATE ZONES OF THE STADIUM AND WITH THE APPROPRIATE TICKET OR SEASON PASS FOR THE ENABLED REDUCE MOBILITY ZONE.
